STALLION SERVICE CONTRACT

THIS STALLION BREEDING CONTRACT for the Breeding Season _____ is made and entered into on this day of /.... /.... By and Between Golden Hills Quarter Horse Stud and hereinafter designated Mare Owner. Mare Owner agrees to breed the Mare Registration Number To '**Doc's Golden Pride**' * for the Fee of **\$1000.00** for a live foal subject to the following conditions. GST will be added to all Invoiced amounts.

1: The Stallion fee includes a non-refundable booking fee of \$300.00, payable upon execution of this contract. **The remainder of the service fee is payable before the semen is shipped.** The first semen collection is free. All other costs incurred will be at the mare owner's expense. If more than 1 dose [shipment] of semen is required, then a fee of \$300 plus freight will apply for each additional dose. **The Balance of all fees/costs must be paid to Golden Hills Quarter Horse Stud on a 42-day pregnancy test. Invoices are payable on receipt.**

2: : Mare owners are responsible for all AI, Veterinary & Freight costs

4:The mare owner hereby agrees that the stallion owner reserves the right to refuse service to any mare which appears to be diseased, unfit or unsuitable for breeding, in the opinion of the stallion owner.

5: This contract contains a "**live foal guarantee**"(LFG). For this purpose a live foal is described as a newborn foal which stands and nurses without assistance. If the foal is born dead, a veterinary certificate must be provided within seven (7) days in which case the mare will be eligible for a return service the following year. A rebreed fee of **\$300.00** plus all other costs, [see clause 1] is payable. **LFG** will not apply to mares that are rebred. The stallion owner is released from all obligations if the mare is rebred and does not produce a live foal. Brood mares, which are bought back into work whilst pregnant, will not be given a LFG regardless of conditions. Mares that are older than eighteen years at breeding will not be given a LFG and will not receive any refunds for any reason.

6: The Mare Owner will meet the Stallion Owners legal costs in relation to any breach of this contract by the Mare owner

7: This Contract represents the entire agreement between the two parties. No other agreements or promises, verbal or implied are included unless specifically stated in this written Contract.

Each party should individually initial additional conditions.

9: This contract is non-assignable and non-transferable.

WHEN THE BREEDER AND MARE OWNER SIGN THIS CONTRACT IT WILL THEN BE BINDING ON BOTH PARTIES, SUBJECT TO THE ABOVE TERMS AND CONDITIONS
