STALLION SERVICE CONTRACT

This agreement is between Sharon Higgins (referred to as the stallion owner) and

.....(referred to as the mare owner).

The Stallion owner hereby agrees to breed the stallion "Doc's Golden Pride" Q943 to the

During the breeding season of

The Mare owner agrees to pay the following fees before the Mare is removed from the Stud.

1. A Agistment fee of **\$3.00 (three) per day** plus gst
2. A Stud fee of **\$1000.00 (One Thousand dollars) plus GST**. Half this said fee of \$575.00 is payable upon the arrival of the mare. The final payment of \$575.00 is payable when the mare is veterinary tested in foal, at the mare owners expense or before the mare leaves the farm.
3. This stud fee holds a '**Live Foal Guarantee**' meaning if the mare fails to produce a live foal that stands and nurses within 24 hours of birth, mare may be returned to the service of the stallion without charge of additional stud fee, provided a licensed veterinarian attests to such occurrence in writing and notification is to the stallion owner within (7 Days) of such occurrence.
Brood Mares, which are **bought back** into work whilst pregnant, will not be given a LFG regardless of conditions. Mares that are older than eighteen years at breeding will not be given a LFG and will not receive any refunds for any reason.
4. Return privileges shall apply only to the next normal breeding season, from August 1 through to December 30. The Live Foal guarantee does not apply to any mare being bred under this privilege. If mare owner fails to return the mare for rebreeding the following year, then all costs paid shall be forfeited, the right to rebreed thereby cancelled and Breeder is released from any further obligation whatsoever. **There will be a \$250.00 mare-handling fee charged for any rebreeds**, plus all other costs, (see clause 1&5).
5. Non-refundable veterinary and farriers fees shall be charged to the mare owner by the stallion owner for appropriate services to the mare (and foal).

The mare owner hereby agrees that the stallion owner reserves the right to refuse service to any mare which appears to be diseased, unfit or unsuitable for breeding, in the opinion of the stallion owner.

It is agreed by the parties hereto that if the Stallion should die, be sold or become unfit for breeding before serving mare or if the mare should die, be sold or become unfit for breeding before being served, this agreement is and shall be null and void.

If arrangements not made to pick up mare and all incurred expenses paid by..... .. date the mare (and foal) will be considered abandoned and will be disposed of at the discretion of the stallion owner.

This agreement and all covenants and agreements herein contained shall be accrued to and be binding upon the parties hereto, their heirs, successors, administrators and executors. Upon material breach of this agreement by one party, the other party may terminate the same.
